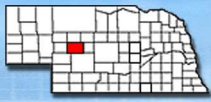
SPECIAL MEETING – JANUARY 27, 2020

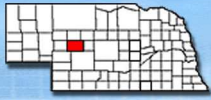

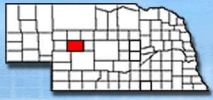

The board received and reviewed the Sandhills RC&D Annual Report.

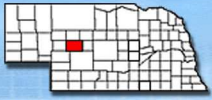
Resolution #2014-13 concerning Regulations for Use of the Courtroom was reviewed by the board. There were no changes made.

Discussion was made on County roads with Ed Black. Ed reported that the county needs some culverts. This was discussed with Rich Cook and will be purchased through Logan County.

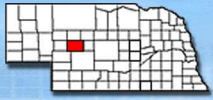
There was a Request for Road Work on North Mail Road. This will be added to the Road Plan and a road will be provided when the house is complete on the property.
