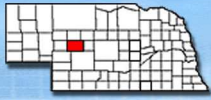
The McPherson County Board of Commissioners met as per adjournment of December 9, 2020 for the annual statutory meeting & regular monthly meeting. Notice of meeting having been published in the Stapleton Enterprise, issue dated January 7, 2021. Chairman Bryant called the meeting to order at 9:03 AM. Board members, Jeffrey Arensdorf, Brett Nason and John Bryant were present. Also present were the Highway Superintendent Tom Werblow, Weed Superintendent Rich Cook, County Attorney Whitney Lindstedt, County Sheriff Tom Burch and County Clerk Kathy Hoberg. There were several members of the public present. The Chairman noted the Public Meetings law which is posted in the meeting room. Nason moved to approve the minutes of the last meeting as presented. Arendsdorf made a motion to appoint Rich Cook as McPherson County Weed Superintendent for 2021 with wages staying at \$12.00 per hour. Bryant seconded. Voting Aye: Arendsdorf, Bryant and Nason. Voting Nay: None.

Discussion was made on the County Roads with Road Worker Ed Black. The road department worked on installing three auto-gates, hauling road cover, and grading roads in the last month. A road was also completed on the Hoffman place.

Bryant moved to set the schedule for Road Overseer as follows:

Jan-Feb-March – Arendsdorf **April- May- June** – Bryant **July-Aug-Sept** – Nason **Oct- Nov- Dec** – Arendsdorf.

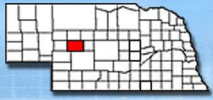

The One-and- Six Year Road Plan Hearing was set for 10:00 AM on Wednesday, February 10, 2021.

The Board discussed the condition and plans for repair on the Soddy Road. There were seven members of the public who asked questions, added input and discussed different options with the commissioners. Tom Werblow, McPherson County Highway Superintendent, gave input about the costs of paving and maintaining the road. The commissioners received a quote for the cost of "Pulverization and Placement of Crushed Concrete" from Level LLC, Robert Watson, owner. Mr. Watson was present and discussed the quote with the commissioners and highway superintendent. There were no decisions made. This matter and all options will continue to be discussed at future meetings.

Bryant moved to approve the January Road Plan as presented by Arensdorf. Nason seconded. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

The board examined quotes from Murphy Tractor for the extended warranty on the John Deere Grader. Bryant moved to approve a 2- year, 2000 hours, Full Machine Comprehensive Extended Warranty for a cost of \$15,600.00. Arensdorf seconded. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

Motion made by Bryant and seconded by Arensdorf to adopt and approve **Resolution #2021-2** appointing Tom Werblow as McPherson County Highway Superintendent, with a total salary of \$9000.00, for the year 2021. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

Motion made by Bryant, seconded by Arensdorf to adopt and approve **Resolution #2021-3** designating the following depositories for McPherson County in 2021. Voting Aye: Bryant, Arensdorf and Nason. Motion made by Bryant, seconded by Arensdorf to adopt and approve **Resolution #2021-4** giving the McPherson County Treasurer the authority to invest funds for the year 2021. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

Bryant moved to adopt and approve **Resolution #2021-5** appointing Whitney Schroeder Lindstedt as the McPherson County Attorney for the year 2021. The hourly wage being set at \$11.00 per hour for 100 hours per pay period, plus expenses, with the same insurance benefits which are offered to all full-time McPherson County Employees. Seconded by Arensdorf. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

Motion made by Bryant, seconded by Arensdorf, to adopt and approve **Resolution #2021-6** appointing Bonnie Edwards of North Platte, Nebraska, to act in the capacity of McPherson County Surveyor for the year 2021. Leo Dailey was present and discussed replacing the outhouse toilets in the Tryon park. Leo will inquire about the cost of renting one and disposing of the old units.

At 9:30 AM the commissioners met with a representative from the Healing Hearts and Families Diversion Program. Representative Jessica presented the board members with information about a Multi-County Three Year Juvenile Services Plan. If awarded, this proposal will allow Healing Hearts & Families to employ Diversion Specialists, responsible for implementing strategies to address the most urgent priorities identified in their Juvenile Services Plan, with a focus on implementing a diversion program along with drug/alcohol and bullying prevention activities for youth. Bryant made a motion to sign a Memorandum of Understanding with the program. Arensdorf seconded. Voting Aye: Bryant and Arensdorf. Voting Nay: None. Absent: Nason.

The commissioners discussed roads with Ed Black. Ed reports that the Road Department has completed 6 auto-gates. There are now a total of 7 auto-gates ready to be installed throughout the county. Also discussed was the need for replacement tires on the back of the drag tractor. These tires will be replaced when needed.

Ed discussed the current condition of the dump and the tree pile in Tryon. The county will look into renting a roll-off container to clean up items which have been placed at the dump. There are many items being taken to the dump which are not supposed to be dumped at that location.

The gate to the tree pile will be closed beginning March 1st. There will be a lock on the gate and a sign directing citizens to call Ed Black or Tom Burch if they need access to the tree pile. The gate will be open on the first Saturday of each month beginning in April. The County requests that TREES ONLY be dumped in the tree pile. There will be a separate pile for grass clippings.

There was a Request for Road Work for building a road leading to a new residence which is under construction off of N. Mail Road in Ward Estates. The county will begin the process of drawing up an easement for the landowner to sign. The request will be re-visited in March, for possible addition to the Road Plan.

The West end of Hall Church Road, where it intersects with Highway 97 was examined and discussed. This area may be involved in the Highway 97 Project which is going to be completed by the State Department of Transportation.

At 10:00 AM, the annual One & Six Year Road Plan Hearing was held in the courtroom. Those present were, Jeff Arensdorf, John Bryant, Whitney Lindstedt, Tom Werblow, Ed Black and Kathy Hoberg. Everyone was given a pamphlet containing the forms and details of the plan. Tom Werblow addressed the board about the plan. Arensdorf made a motion to adopt and sign **Resolution #2021-11** adopting the One & Six Year Road Plan for 2021. Bryant seconded. Voting Aye: Arensdorf and Bryant. Voting Nay: None. Absent: Nason. The hearing was closed at 10:30 AM.

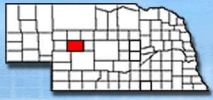
Caleb Johnson was present and addressed the commissioners about the upcoming budget season. Bryant moved to sign a two-year agreement with Johnson for preparation of the budget documents and summaries and submission of the document to the Nebraska Auditor of Public Accounts. The fee to the county will be \$1700.00 plus mileage for each fiscal year. Arensdorf seconded. Voting Aye: Bryant and Arensdorf. Voting Nay: None. Absent: Nason.

There was a Safety Committee Meeting held with presentation of Covid Safety Measures given by Tom Werblow. Present for the meeting were, Jeff Arensdorf, John Bryant, Whitney Lindstedt, Kathy Hoberg and Ed Black.

Motion made by Bryant, seconded by Arensdorf to adopt and sign **Resolution #2021-8**, authorizing the County Attorney and McPherson County Sheriff to retain Jon S. Schroeder on a per case basis to represent the County when the County Attorney is unavailable and in the event the County Attorney has a conflict of interest that prevents her from representing McPherson County. Voting Aye: Bryant and Arensdorf. Voting Nay: None. Absent: Nason.

Bryant moved to adopt and sign **Resolution #2021-10** Agreement between the County of McPherson and State of Nebraska, Department of Transportation, concerning the improvement project of Highway N-97. Arensdorf seconded. Voting Aye: Bryant and Arensdorf. Voting Nay: None. Absent: Nason.

Kathy Hoberg, McPherson County Assessor, presented the board with a Tax List Correction for Personal Property Schedule #600044066. There was a clerical error on the schedule which requires a correction to the Tax Roll. The Correction was signed by Vice-Chairman Arensdorf.

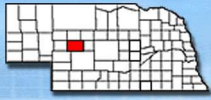

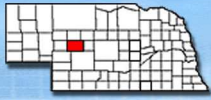

The county is waiting for response from the Village of Stapleton on this issue.

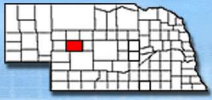
A request for road work at 40 N Mail Road, Ward Estates, was placed on the road plan.

Bryant moved to approve the Road Plan which was presented by Arensdorf. Nason seconded.

Voting Aye: Bryant, Nason and Arensdorf. Voting Nay: None.

The commissioners decided that the scrap v-plows which are rusted and obsolete, will be hauled away and sold as scrap iron.

Jeff Arensdorf reported that he had been approached about an overlay that Lincoln County will be conducting on Prairie Chase Road. An inquiry was made as to whether McPherson County wanted to overlay the mile entering our county. The commissioners decided it is not in the road budget and the county will not participate in this road project.

Doye Miller arrived and discussed a request which he had submitted for a road crossing permit, placing a water line beneath Brooks Street from Block 5 to Block 6 in Tryon. Bryant made a motion to approve and sign the permit, upon signature by Mr. Miller. Arensdorf seconded. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

A Safety Committee meeting was held. Tom Werblow gave flyers and information about how to respond to Difficult and Threatening Behavior.

At 10:00 the regular meeting was recessed and a Board of Equalization meeting was called to order.

Chairman of the BOE, Jeff Arensdorf, noted the Open Meetings Law which is posted in the meeting room. Those present were, Chairman Arensdorf, Brett Nason and John Bryant. Also present were the county attorney, highway superintendent and the county assessor. The board examined the current Permissive Exemption Forms 451A. These did not need board approval as they are re-affirmation forms.

The County Assessor discussed the 2021 Ag land values for Irrigated, Dryland and Grassland classes. There will probably be an increase in value for Grassland. Irrigated and Dryland will see no change for the 2021 tax year. Values are set by a statistical sales study from October 1, 2017 to September 30, 2020. McPherson County will conduct a mass appraisal in 2021, with a new depreciation schedule being put into place. Value changes to residential and commercial properties, resulting from that appraisal, will take effect in 2022.

The meeting of the Board of Equalization was adjourned at 10:10 AM.

The regular commissioner's meeting reconvened.

Arensdorf made a motion to adopt and sign Resolution # 2021-9 Equipment Maintenance to be paid from the Inheritance Fund. Bryant seconded. Voting Aye: Arensdorf, Bryant and Nason. Voting Nay: None.

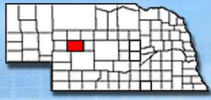

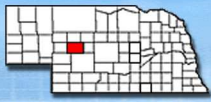

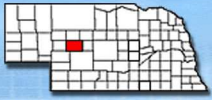

At 9:20 AM, there was a Safety Committee Meeting held. Those present were, Tom Werblow, Whitney Lindstedt, Brett Nason, Jeff Arensdorf, John Bryant and Kathy Hoberg. Tom Werblow gave flyers and a presentation on "How to Prevent a Physical Attack". John Bryant also reported that he did a "walk- through" of the county road shop. Bryant said the shop was clean and orderly.

Tim Vanderheiden, McPherson County School Superintendent, was present and recognized by the board. Mr. Vanderheiden inquired about the asphalt road/parking area in front of the high school. The area needs repairs and asphalt patch. Ed Black will contact the state highway department about whether they will repair this area or if they want the county to complete the work.

At 9:45 AM, the commissioners visited with Mike Kelly from Buckboard Ranch LLC who was present to discuss a project on Prairie Trace Road. The Lincoln County road department is re-paving this road and offered to let McPherson County join the project at a cost of \$134,000 for the mile into McPherson County. The cost of this project is not an expense that the county budget can withstand at this time. Mike Kelly, who is also associated with Western Nebraska Bank, informed the board that WNB would be willing to finance the project at a low interest rate. McPherson County has additional paved roads needing repair which continue to be

under review by the commissioners. The board did not think it was prudent to take on the expense of paving the mile of Prairie Trace Road in light of the problems with all of the paved roads in the county. Further discussion was held about the possibility of changing the mile of road to a covered, gravel road. This project has been and is currently on the road plan.

At 10:00 AM, Eric Kamler from Congressman Adrian Smith's office, joined the meeting via telephone. Mr. Kamler gave updates on policies and current issues.

The 30x30 Project set forth by Executive Order was discussed with the commissioners. At this point there have not been enough details from the Administration about exactly what the process of this project will be or what their real plans are. Mr. Kamler said that the Congressman is keeping a close eye on this project and they are waiting for more details to emerge. They recognize the importance and concerns related to this issue and will forward information, as soon as possible, to the citizens of the counties and State of Nebraska. The board made no decisions at this time concerning the 30x30 Project. The matter will be revisited at the regular meeting in May.

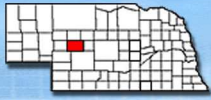
At 10:30 AM, Rich Cook was present to visit with the board about contracting with the county as McPherson County Veteran's Service Officer. Randy Fisher, Terry Neal and Harold Arensdorf were also present to discuss the matter with the commissioners. The board agreed that it would be beneficial to have a local Veteran's Service Officer and set up a local complete data base of Veterans in McPherson County. The county currently has a contract with Lincoln County for this position and the process of changing this arrangement will be examined. The board discussed roads with Ed Black. Ed reports that they have been grading roads, repairing water holes and hauling gravel throughout the county. There were eleven loads of crushed concrete applied to roads in the county. The commissioners discussed the need for ten loads of crushed concrete needed for a project on Pioneer Road.

There was discussion about the obsolete V-plows which are at the tree pile in Tryon. Bryant made a motion to declare the V-plows surplus property to be sold when they can be readily accessed. Nason seconded. Voting Aye: Bryant, Nason and Arensdorf. Voting Nay: None. Arensdorf made a motion to approve the April Road Plan as presented by Bryant. Nason seconded. Voting Aye: Bryant, Nason and Arensdorf. Voting Nay: None.

Bryant made a motion to approve and adopt Resolution #2021-13 giving the Treasurer authority to transfer \$22,000.00 from the General Road fund into the Inheritance Fund. The money was previously transferred from Inheritance to Road for a project but was not used. Arensdorf seconded the motion. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None. Resolution #2021-14 Second Amendment was discussed. There was much discussion about the purpose and effectiveness of the resolution. Included in the discussion were the commissioners, the county attorney and the county sheriff. There were members of the public present who were in favor of adoption of the resolution. Arensdorf moved to approve and adopt Resolution #2021-14, declaring McPherson County's support of the Second Amendment to the United States Constitution and Article I Section 1-1 of the Nebraska Constitution. Nason seconded. Voting Aye: Arensdorf and Nason. Voting Nay: Bryant. The board discussed the two positions which need to be filled on the Planning Commission. The two current members have been contacted and the board is waiting for a response. The commissioners will also be contacting Planning Commission Members about the need to have regular meetings.

The commissioners reviewed and signed the quarterly reports from the county clerk and county sheriff.

The treasurer submitted a report to the board informing them that there will be a fund

created solely for the money the county will be receiving from the American Rescue Plan Act. This will be "Fund 2580 COVID American Rescue Plan" with Revenue Code 339.25. This money is scheduled to be allotted to counties sometime in 2021, with a deadline for use of 2024. The use of the money will be narrowly restricted to approved projects only. The details of these have not yet been released by the Federal Government.

The county assessor presented a Tax List Correction due to a Homestead on parcel #600001881 which was rejected by the State following an audit of 2018 Homestead Applications. This was signed by the commissioners.

The assessor also informed the commissioners of a report of Omitted Property after the Abstract was filed. The property was a building on parcel #600015157. The building has now been added to the parcel.

The assessor presented the board with a copy of Reports and Opinions from the Property Tax Administrator. The PTA approved the level of value for McPherson County to be at 100% for Commercial and Residential Property and 75% for Ag-land. The assessor reports that values for 2021 in McPherson County have been set at \$2100 per acre for irrigated ag-land, \$725 an acre for dryland and \$495 an acre for grassland. This is no change for irrigated and dryland and a 10% increase in value for grassland.

There will be a mass appraisal conducted in the county in 2021. Bryant made a motion to approve an estimate of cost from Central Plains Valuation of \$25,100.00. Arensdorf seconded the motion. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

The commissioners signed a letter from Donald D. Wilson who recently completed an audit of all offices in McPherson County.

The date of the June commissioner's meeting was moved from June 9th to June 8th. The date was moved due to the Clerk's Workshop which will be held in York, NE on June 9-11, 2021.

The Commissioners will also be attending a workshop in Kearney on the same dates.

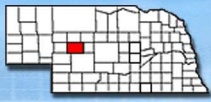
The June 8, 2021, Commissioner's Meeting will be held in the courthouse in Tryon and will begin at 9:00 AM.

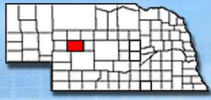

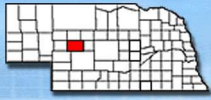

The board discussed repairs needed to the garage next to the courthouse. They will receive and review a bid from Roxy's Roofing when it has been completed.

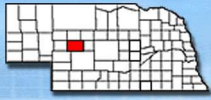

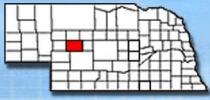

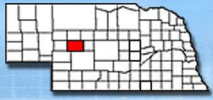

Bryant seconded. Voting Aye: Nason, Bryant and Arensdorf. Voting Nay: None.

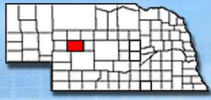

Ed informed the commissioners that the Payloader will be going in for repairs by next week.

In addition to the above salary, each official shall receive the same health and medical group insurance plan as offered to all elected county employees, which is up to employee/spouse insurance coverage or receive a monetary payment of \$1,000.00 a month at county expense, during his or her term of office. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

The commissioners approved the addition of grub prevention to the current contract agreement with Trugreen, for lawn care at the courthouse.

There being no further business, the meeting was adjourned at 11:05 AM
