The McPherson County Board of Commissioners and Board of Equalization met as per adjournment of December 11, 2023, for the annual Reorganizational meeting and regular monthly meeting. Notice of meeting having been published in the Stapleton Enterprise, issue dated January 4, 2023. Chairman Arensdorf called the meeting to order at 9:00 AM. Board members Jeffrey Arensdorf, Brett Nason and John Bryant were present. Also present were the Highway Superintendent Tom Werblow, County Attorney Whitney Schroeder, County Sheriff Tom Burch, and County Clerk Kathy Hoberg. Road employee Ed Black was also present. The Chairman noted the Public Meetings Law which is posted on the North wall of the meeting room. Bryant moved to approve the minutes of the last meeting as presented. Nason seconded. Bonnie Edwards of North Platte has retired and recommended Dickinson Land Surveyors. After speaking with Mr. Dickinson and reviewing his information packet, Nason moved to approve and adopt **RESOLUTION # 2024-1** Appointing Dickinson Land Surveyors of Ogallala, NE, to the position of **McPherson County Surveyor** for 2024. Ed Black addressed the board about the need for a new dump truck. The 1998 Freightliner has been deemed beyond repair. Nason moved to declare the **1998 Freightliner Dump Truck**, surplus property, to be sold on Big Iron. Included in the motion are 4 V-Plows which are no longer in use. Josh Streiff was present and addressed the board concerning a meeting of the school board and the Nebraska Association of School Boards which was held on January 25th at the High School. The school board would like the commissioners to collaborate with them in a community engagement program through NASB. The county is researching legal aspects of engaging in the program. This will be discussed again at the March Board meeting.

At 9:30 AM the commissioners held an interview with Kenneth C. (K.C.) Bang of Decatur NE. who had applied for the County Sheriff’s position. Mr. Bang has been a Certified Law Enforcement Officer with the State of Nebraska since 1984. After discussion, Bryant made a motion to hire Kenneth C. Bang for the position of McPherson County Sheriff. Arensdorf seconded the motion. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

Robert Watson was present and discussed the Soddy Road Project with the commissioners and Highway Superintendent Tom Werblow. The board is collecting information about the best way to proceed with pulverizing the asphalt and the best material to mix with the asphalt prior to laying it down as a road base. There were several members of the public present. Rudy Haynes, Pamela Haynes, Josh Streiff, Jack Tucker, John Tucker, Kasey Dailey, and Ed Black, each gave input and asked questions.

At 10:00 AM, a **One-and Six-Year Hearing** was held. Tom Werblow presented each board member with a copy of the One-and Six -Year Road Plan. Werblow explained each page of the plan which describes each project within the county. There were members of the public present, but no public input to the hearing. Nason moved to approve and adopt **RESOLUTION #2024-7** Adopting the 2023-2024 One-and Six-Year Road Improvement Program. Arensdorf seconded. Voting Aye: Nason, Arensdorf and Bryant. Voting Nay: None.

The Board had previously published and posted a **Notice to Bidders** requesting **sealed bids** for a Dump Truck. The board received one sealed bid which was opened and read at 10:30 AM. The bid was beyond the age and specifications of the Notice to Bidders. Bryant made a motion to deny the bid. Nason seconded. Voting Aye: Bryant, Nason and Arensdorf. Voting Nay: None.

Ed Black reported that the road department has been dragging and grading roads. Ed also gave an update on repairs which have been completed on the Western Star Semi Truck. Bryant made a motion to approve the February Road Plan as presented by Arensdorf. Nason seconded. Voting Aye: Bryant, Nason and Arensdorf. Voting Nay: None.

The board discussed a renewal to the JD Link subscription on the John Deere 770G Grader. The subscription was renewed. There were no fees for the renewal.

There was a Safety Committee Meeting held. Those present were, Tom Werblow, John Bryant, Brett Nason, Jeff Arensdorf, Kathy Hoberg, Kasey Dailey, and Ed Black. Tom Werblow gave flyers and information about *Safe Operation of All-Terrain Vehicles*.
